### BACKGROUND OF CALL:

Jurisprudence, or legal theory, is the theoretical study of law. Scholars of jurisprudence seek to explain the nature of law in its most general form and provide a deeper understanding of legal reasoning, legal systems, legal institutions, and the role of law in society. Global development on the other hand refers to the development of greater quality of life for humans. The concept covers issues such as sustainable governance, health care, education, gender equality, social and political infrastructure, economics, human rights, environment and other social issues with political index. The theme of the Conference is "Jurisprudence for Global Development" and the objective is to explore a meaningful jurisprudence, that will not only ground but interface with contemporary global development agenda.
