Take a Tour to Faculty of Law – VC Charges Deans, HODs

The Vice-Chancellor, Prof. Charles Igwe has charged all the Deans and Heads of Department to take a tour to the Faculty of Law to understudy the faculty's system of revenue generation and problem solving.

Prof Igwe gave the charge

recently, when he commissioned string of projects and endowments in the faculty. The projects were sponsored using revenue generated from alumni and friends of the faculty by the past and current Deans.

The projects commissioned

included: Professor Gaius Ezejiofor, SAN, Law Clinic; 100KVA power generating set; a brand new project vehicle; Professor Edwin Nwogugu Postgraduate Room; Prof Ben Nwabueze, SAN, Faculty of Law Boardroom and Prof. Gaius Ezejiofor Departmental Boardroom.

Also commissioned were a total of 160 office chairs; Professor Denis Ewelukwa Faculty Lounge and Justice Centus Chima Nweze Moot Court.

“Faculty of Law has made us proud, they have shown us a good example”, Professor Igwe said, urging other Deans and HODs to emulate the strategy of the faculty.

The Vice-Chancellor praised the commitment of the current Dean and past deans of the faculty in mobilizing resources to upgrade infrastructure in the faculty.

“I am very proud of ex-Deans of this faculty: they have maintained a development succession plan that is result
